**RESOLUTION ESTABLISHING PUBLIC HEARING ON  
PRELIMINARY FY2020 BUDGET AND TAX RATE**

WHEREAS, a public hearing on the proposed budget for the City of East Lansing is required by City Charter and the State Budget Law; and,

WHEREAS, a public hearing is required under the provisions of the Truth in Taxation Law; and,

WHEREAS, the general appropriations act must set forth the total number of mills to be levied and the purposes for the millage;

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of East Lansing does hereby establish the date of Tuesday, May 7, 2019 at 7:00 p.m., in 54-B-Court Room 2, City Hall, 410 Abbot in East Lansing, Michigan, as the date, time, and place for the required public hearing; and be it further resolved that for the purposes of the hearing it shall be assumed that the total tax rate will be **16.3552 mills consisting of 12.5362 mills for operating purposes, 1.8250 mills for solid waste, and 1.9940 mills for the Library pursuant to section 1 of 1877 PA164.**

**The property tax millage rate proposed to be levied to support the proposed budget will be a subject of this hearing.**

The budget is available for public inspection at the East Lansing Library and City Clerk and Finance Office at City Hall; along with the City's website: [cityofeastlansing.com](http://cityofeastlansing.com) under Finance.

Public comments, either oral or written, are welcome at the Public Hearing.
